Prior to the submission of servicing plans, the owner shall, to the satisfaction of the Director of Planning Services, provide an updated geotechnical report prepared, signed, sealed, and dated by a geotechnical engineer licensed in the Province of Ontario. Said report shall, as a minimum, provide factual information on the soils and groundwater conditions within the proposed development. Also, the report should include design information and recommend construction procedures for any proposed storm and sanitary sewers, stormwater management facilities, watermain, roads to a 20 year design life, the mass filling of land, surface drainage works, erosion control, slope stability, slope treatment and building foundations. Included in this report must be details regarding the removal of substandard soils (if any) and placement of engineered fill (if required) for the construction of homes. Also, the report must include an analysis illustrating how the groundwater table will be lowered to a level that will not cause problems to adjacent boundary housing and will, in conjunction with the subdivision grading plan, show that basements of new homes will not require extensive foundation drainage pumping. The geotechnical information on building foundations shall be to the satisfaction of the Chief Building Official and Director of Planning Services."

- e) By adding a new Condition #30 as follows:

"30. Prior to any vegetation removal or other site alteration on the subject lands, the owner shall consult with the Ministry of Natural Resources with respect to the presence of any species at risk under the Endangered Species Act. The owner shall demonstrate to the satisfaction of the Director of Planning

including the required curbs and gutters, and sidewalks.”

b) By adding a new Condition #32 as follows:

“32. The owner shall provide proof of sufficient fire flow in
conjunction with the submission of construction drawings for each
phase of construction. All costs associated with upgrading the
existing distribution system to service this subdivision will be
borne totally by the owner.”

c) By adding a new Condition #33 as follows:

“33. The owner shall provide proof of sufficient sanitary sewer
capacity in conjunction with the submission of construction
drawings for each phase of construction. All costs associated with
upgrades to the downstream works required to service this
subdivision will be borne totally by the owner.”

d) By adding a new Condition #34 as follows:

“34. As part of the submission of servicing plans, the owner
shall have rear yard slope treatments designed by a geotechnical
engineer licensed in the Province of Ontario incorporated into the
lot grading plans if noted as required at locations required by the
Director of Planning Services. Suitable provisions shall be
incorporated into the Subdivision Agreement to ensure that the
treatment is undertaken to the satisfaction of the Director of
Planning Services.”
