	AND WHEREAS there are no current policies/by-laws governing the naming of a program on behalf of an individual;
	AND WHEREAS the naming of a program does not fall under the Corporate Sponsorship policy, the Parks Services Memorial Donation program, or the Building, Property and Park Naming policy;
	THEREFORE BE IT RESOLVED THAT the City of Greater Sudbury approves the naming of the Bell Park Gazebo Concert Series program after Mr. Peter Schneider.

Beach Supervision	Councillor Kirwan asked if it would be possible for beaches to be supervised until the end of labour day weekend.
	The Director of Leisure Services responded that a large majority of employees are college and university students who return to school during that time and that there would also be additional costs associated with the additional supervision. He noted staff does have the flexibility to expand the season based on variables including weather.
