



WHEREAS the Ministry of Health and Long-Term Care (MOHLTC) classifies long-term care beds for structural compliance and provides a capital per diem at the rate of approximately 50/50 cost sharing to those homes which fall below an "A" standard of structural compliance;

AND WHEREAS Pioneer Manor has been identified as having 149 of its 433 beds below the "A" standard of structural compliance qualifying it for capital redevelopment funding from the Ministry of Health and Long Term Care;

THEREFORE BE IT RESOLVED THAT the City of Greater Sudbury prepare a business case for Pioneer Manor Bed Redevelopment for consideration in the 2019 City of Greater Sudbury budget process;

AND THAT in preparation for the 2019 budget, an RFP be issued to secure an architect to prepare schematic design for the capital redevelopment, and subject to Council authorization in the 2019 budget, the same architect be secured for detailed design, tender and oversight of the capital project;

AND THAT the City of Greater Sudbury issue an RFP to secure an outside party to procure and recommend a business opportunity for the future vacated 59,000 square feet of space for the 2019 budget which would complement the seniors campus model and also contribute annual revenue to offset the municipal contribution of the capital redevelopment project for the 149 long term care beds as outlined in the report entitled "Pioneer Manor Capital Redevelopment" from the General Manager of Community Development, presented at the City Council meeting on November 22, 2017.
